Join us on the occasion of the Rochester Art Center's 70<sup>th</sup> Anniversary with an expanded version of our popular Think and Do Family Day event! All events are free and open to the public—come anytime and stay 5 minutes or 5 hours!

We'll have our doors open to Mayo Park from 1:00p – 4:00p with art making activities, live music, lawn games and good times with friends and family. Among the nearly 20 activities available to the public include: exhibitions tours, a new play/make/learn exhibition, a project space to build your own bone sculpture, video and films on the exhibiting artists, radical fabric making, a poetry slam, spin art, spoke cards, outdoor movies, selfie stations and listening to live, local bands and DJs amidst a variety of artsy lawn games. We'll also have a few surprises throughout the day, including a cake worthy of a 70th Anniversary!

RAC will also have activities inside the Art Center, including drawing stations and one of the earliest viewings of our new Eamon O'Kane *Froebel* exhibit. Galleries featuring the *Unearth:* Judy Onofrio exhibition will also be open for a sneak peek before that evening's Exhibition Opening. Also on view is *When Lost in the Woods* by Melissa Borman.

RAC is also collaborating on this event with Art4Trails, a public art project of the Rochester Arts and Culture Collaborative, to support local and regional artists and bring public art to the bike trail near downtown Rochester. This project provides an opportunity for five local artists to demonstrate their talent by creating and installing their sculptures in their own community. Two sculptures will be located along with bike path that runs the Zumbro River. Sculptures are located on the East side of Mayo Park, one sculpture on the West side of Mayo Park, one in Slatterly Park and one near the fire station in Silver Lake Park.

Art4Trails artists were selected in a competition for based on proposals from local artists. The winners of this competition each receive \$2,000 for supplies and materials to develop their art. The selected artists are:

Departing at noon from Silver Lake Pool parking lot, Art4Trails will conduct a bike ride past each of the chosen art sculptures, with artists at each station describing their work. The ride will conclude at Mayo Park by approximately 1:00p.

- Richard Brubaker: sculpture title, *Sunrise Sunset*, to be located on the East side of Mayo Park. The artist has donated this piece to the City of Rochester, and it will be a permanent installment.
- Chris Delisle and Crist Dahl: sculpture title, *Bags of Leaves*, to be located on the East side of Mayo Park. This art will be in place for up to one year. This piece is also available for purchase; please contact the artist for details.
- Judd Nelson: sculpture title, *Blue Heron with Pumpkin Seed*, to be located on the West side of Mayo Park. This art will be in place for up to one year. This piece is also available for purchase; please contact the artist for details.
- Andrew Arend: sculpture title, Giant Fish, to be located near the bike trail in Slatterly Park. This art will be in place for up to one year. This piece is also available for purchase; please contact the artist for details.
- Joshua Schroeder: sculpture title, *Treecycle*, to be located near the fire station in Silver Lake Park. This art will be in place for up to one year. This piece is also available for purchase; please contact the artist for details.
